

## Origins Panel Material Warranty

**Yemm & Hart Ltd ventures to bring** to the building owner, architectural specifier and contractor a post-consumer recycled polyethylene product designed to compare in performance with other polyethylene panels. We believe in our products, and back them with the following warranty:

Origins panels manufactured by Yemm & Hart and sold under its name are warranted by the manufacturer to the purchaser to be free from manufacturing defects in workmanship of material, for a period of fifteen (15) years from the date of receipt by customer. This warranty is subject to the following conditions:

1. The Origins panels have been installed in accordance with the manufacturer's written instructions.
2. The warranty is effective only with regard to the original sale of the Origins panels and not to any subsequent installation or use without the consent of the manufacturer.
3. The warranty shall not be applicable if the defect in the Origins panels has resulted from any failure or defect in the building or substructure to which the Origins panels are attached (including but not limited to setting, shifting, distorting, or movement of the walls or foundation of the structure), extraordinary wear and tear, passive or violent action of the elements (such as sunlight, lightening, hurricane, tornado, or hail), vandalism, misuse, neglect, or improper handling of the Origins panels before, during or after installation, or improper or insufficient ventilation of the building to which the Origins panels are attached.
4. The user or their agent, purchases the Origins panels for use in their building and owns the building or substructure to which the Origins panels are attached on the date that a claim is made under the warranty.

Subject to the above conditions, in the event that the Origins panels are found to be defective in workmanship within fifteen (15) years from the date of receipt by customer, the manufacturer, free of charge will exchange new Origins panels for defective Origins panels. This warranty is limited to the exchange, upon receipt by the manufacturer of the defective Origins panels, of new Origins panels for defective Origins panels. The manufacturer will not pay any removal, installation costs or any other labor costs associated with the exchange of the Origins panels, including return freight. At its sole option, the manufacturer in lieu of exchanging new Origins panels for defective Origins panels, may refund the customer the sales price received by the manufacturer, upon receipt by the manufacturer of the defective Origins panels.

The Origins panels are only warranted to be free from defects in workmanship as set out above. This warranty shall be the sole and exclusive remedy to the customer for the Origins panels. The manufacturer shall not be liable for incidental or consequential damages resulting from failure or defect in the Origins panels. No representative has the authority to make any affirmation of fact or promise which relates to the Origins panels except as stated herein.
